- ii. Ex: motel 6 homicides, drugs etc inspection with code enforcement, fire marshal to come up with a plan to help cut down on crime
- ii. Multi Family Housing Project can go give presentation to residents at request properties call them.

 - 1. Largest PRT team in the city!
- ii. Q: SE Corner of San Pedro/Central people crossing road
 - 1. A: hot spot area reached out to owner of shopping center. Asked to put up tresspasig sign to make contact with those people. Circle K sells liquor that's the issue
- iii. Good samaritan donated \$2k area command purchased socks
- iv. Q: ADAPT eastern/san pedro efforts of getting a fence up there
 - 1. A: Diego: code enforcement can't reach owner

e. Carol Pierce

- i. Gateway System homeless coordinating council is looking at all the gateways to connect to get people service
 - 1. Smaller shelters 100 beds, 150 beds --multiple entry points
 - 2. We need 750 emergency beds BUT we need housing and services to go with these beds. What is the plan? What is the exit strategy? How do we get people what they need?
 - 3. Talking with hope works in downtown area as well as Gibson
 - 4. Shelter is only a piece of the problem but they need connections to more.
- ii. Q: are there plans to deal with it in the meantime
 - 1. Westside shelter getting renovation \$1m
 - 2. Westside is piece of the gateway but need the other pieces in town
- iii. FY22 budget coming up asking for more housing resources
- iv. \$2m for rapid rehousing
- v. D6 needs more behavior health resources
- vi. Also gaps in substance abuse treatment
- vii. City has money to help people pay rent in arrears!
 - 1. \$1m for eviction and arrears
 - 2. Can pay up to 12 months of rent
 - 3. Mortgage finance authority city and county
 - 4. Contact Gilbert/Carol to connect families with these resources.
